- Tuition fees for students residing in the Canton of Lucerne or in a partner canton\*
  - . Fulltime CHF 803
  - (incl. CHF 3 membership fee for the student organization SUMO)
  - Part-time CHF 503
- *Students from cantons without an agreement pay an additional fee on top of the regular semester tuition*
  - . Full-Time CHF 8050
  - . Part-time CHF 4900

  - . Part-Time CHF 30
