

**Costs for the Master of Science in Business Administration  
with a Major in Business Innovation & Entrepreneurship**

Academic Year 2026/27

The following table provides an overview of the approximate outlay during the course and is intended as an aid in drawing up individual budgets. The fees are based on the corresponding regulations of the Lucerne University of Applied Sciences and Arts<sup>1</sup>. Please note that fees may be subject to change and that non-fee figures should be taken as approximations only.

- The application fee is charged during the online application process. There will be no refund if you cancel your application or if you are not admitted into the programme.
- Tuition fees must be paid in full by all students who are registered at the beginning of semester. Such fees are also owed in case of deregistration after the start of the semester (even if no classes have been attended).

The Lucerne University of Applied Sciences and Arts does not receive cantonal funding for students who were not residing in Switzerland before starting their studies. The Lucerne University of Applied Sciences and Arts covers the majority of the resulting funding difference. However, to cover the remaining difference, the semester fees for these students are slightly higher (CHF 1,300 vs. CHF 800 per semester) than for those who were residents of Switzerland prior to their studies (Swiss nationals or holders of a residence permit not issued for study purposes).

#### **Are there any student dormitories?**

There are some student dormitories in or around Lucerne. Please find detailed information on:

You might also find a flat together with two or three other students for about CHF 600.- to 1,200. - per person and month.

#### **Am I allowed to work in Switzerland with a student visa?**

Yes, you are under certain circumstances and subject to certain restriction depending on your residence status. Generally speaking, EU-nationals can work up to 30% of a normal workload from the first day on. Non-EU-nationals can work from the seventh month onwards.

#### **Is it possible to find work without speaking German?**

Some of our non-native-German-speaking students have been successful in finding a job without fluent knowledge of German. However, it is not easy to find something without any ability in the language. If you find a job, you can expect a salary of about CHF 500.- to 1,000. - per month when working 30% of a normal workload. In addition, many international companies are located in Central Switzerland or Zurich.
