

**Costs for the Master of Science in Business Administration Academic Year 2021/22  
with a Major in Online Business and Marketing**

The following table provides an overview of the approximate outlay during the course and is intended as an aid in drawing up individual costs. The fees are based on the corresponding regulations of the Lucerne University of Applied Sciences and Arts<sup>1</sup>. Please note that fees may be subject to change and that non-fee figures should be taken as approximations only.

- The enrolment fee is charged during the online application process. There will be no refund if you cancel your application or if you are not admitted into the programme.
- Tuition fees must be paid in full by all students who are registered at the beginning of semester. Such fees are also owed in case of deregistration after the start of the semester (even if no classes have been attended).

## **Frequently asked questions concerning financial matters:**

### **What is the cost of living?**

The cost of living and tuition (including expenses for accommodation, insurance, food, transportation, limited leisure activities, etc.) is about CHF 18,000 per calendar year.

### **Are there any student dormitories?**

You might also find a flat together with two or three other students for about CHF 1,800.- to 2,200.- per month per flat.

### **Am I allowed to work in Switzerland with a student visa?**

Yes, you are under certain circumstances and subject to certain restriction depending on your residence status. Generally speaking, EU-nationals can work up to 30% of a normal workload from the first day on. Non-EU-nationals can work from the seventh month onwards.

### **Is it possible to find work without speaking German?**

Some of our non-native-German-speaking students have been successful in finding a job without fluent knowledge of German. However, it is not easy to find something. If you find a job, you can expect remuneration of about CHF 500 to 1000 per month when working 30% of a normal workload.
